Bequests

You can keep the music playing well beyond your lifetime by including *the Phil* in your **will or estate plans**. Simply share the following statement with your attorney or financial planner:

"I bequeath \$_____ or _____% of my estate to the Plymouth Philharmonic Orchestra, P.O. Box 3174, Plymouth, MA 02361."

Beneficiary Designation

Add the Plymouth Philharmonic (Tax ID# 23-7267-766) as a beneficiary of your 401(k), IRA retirement accounts, or life insurance policy. Consider naming *the Phil* as the charitable successor on your Donor Advised Fund (DAF). Doing so only requires a simple form and a few moments of your time.

Other Options

Working with your financial advisor or attorney, you may decide to use other gift options to help achieve your philanthropic goals, today and for the future. *The Phil* is able to accept gifts from charitable remainder trusts, IRA rollovers, qualified distributions from retirement accounts, stocks, mutual funds, donor advised funds, and more. *The Phil's* staff will gladly talk through your options and decisions when you are ready.
